SUBJECT:	Fall 2025 Bama Works Grant

Recommended action:

Approve the attached resolution to accept and appropriate \$2,500.00 for the Fall 2025 Bama Works Grant for the Greene County Animal Shelter.

Background:

The County has been awarded \$2,500.00 from the Bama Works Fall 2025 Grant Cycle for the purchase of a 10-foot bank of stainless-steel cages with wheels. These enclosures allow for the safe housing of smaller dogs rather than the larger runs in the building and allow for the ability to house more animals. The Animal Shelter cannot house dogs for long term as it is very small and is meant to only temporarily house dogs before adoption--either strays, surrenders, or those taken by authorities. The building's runs are concrete with painted floors with large drains in the floor for easier cleaning. The Virginia Department of Agriculture has found faults during inspections regarding the large drains as being a potential issue for smaller dogs and puppies. According to state code 2VAC5-11-20(A) each facility shall be kept in a clean, dry, and sanitary condition and safely house and allow for adequate separation of animals. Inspections have noted that the current set-up does not allow for the safe housing of dogs with smaller feet due to the nature of the drains in the floors. The top 4 cages are 30"

by 30” high and 28” deep. The 2 bottom cages are 60” by 36” high and 28” deep (with a divider to make 2 cages). This bank is on a stationary base. We will utilize the Local Assistance and Tribal Consistency Fund dollars that remain in the account and identified and allocated for matching funding for grants to pay for the full cost of the system, which is \$7,500.00.
